# NATIONAL WORKSHOP ON "STRATEGIES FOR ENHANCING AGRICULTURAL AND RURAL PRODUCTION IN A POST COVID-19 ECONOMY"

#### Rationale

Agriculture is a vital sector for the sustained growth of developing countries, especially agriculture-based countries such as those in sub-Saharan Africa. Equally important is the fact that a significant portion of the world's population—86 percent of rural inhabitants—still depends on agriculture for employment and sustenance (World Bank 2007), demand for food is increasing too. The International Food and Policy Research Institute (IFPRI) estimates that an additional 6 million hectares of maize and 4 million hectares of wheat plus a 12 percent increase in global maize and wheat yields will be needed to meet demand for cereals alone in the next decade (Edgerton 2009).

Extension services and improved farm inputs are delivered to farmers under the agricultural component of rural development programmes so as to motivate the adoption of improved technologies that will ensure efficient utilization of resources deployed to agricultural productivity improvement, in other words, transfer of improved technology for optimum allocation and utilization of resources.

More intensive utilization of agricultural resources (land, seeds, fertilizer, implements and prime movers) is encouraged, and land development techniques are incorporated into rural farming. Also, the land – man ratio as well as input-output ratio is resultantly *improved for farm income and purchasing power of the farmer.* 

These can only be achieved through efficient extension services systems, which are the vehicles through which they are conveyed, for effective agricultural productivity improvement.

It is in realization of the above that the National Productivity Centre is organizing a National Workshop on "Improving Agricultural Productivity through Effective Extension Service Systems".
